Subject: Notice for Trade Union Action Programme for redressal of staff grievance and demand.

Sir,

We are constrained to mention that unwarranted, partisan and motivated transfers have been ordered at many places viz. Andhra, Gujrat, A & N, Tamilnadu, Rajasthan, Orissa, Karnataka, MP, Maharashtra and other Circles in violation of the transfer policy issued by corporate Headquarter. The respective CGMs are reluctant to rectify the impugned orders.

Further, there was consensus in the meeting held on 12-11-2008 between unions and management in presence of Dy. CLC for grant of minimum Trade Union Facilities. There is no progress in this respect also.

Wage revision for non-executives employees is unduly delayed. Both management and recognized union are acting against the interest of the workers.


Therefore, in accordance with the provisions contained in sub-para of section 22 of the Industrial Dispute Act, the unions of "BSNL Workers Alliance" hereby notify to resort to the following Trade Union Action Programme to focus the attention of the management for redressal of grievances and settlement of issues given below:-

1. Early wage settlement for Group "C" and "D" employees
2. Cancellation of all transfers issued in partisan and violation of transfer policy.
3. Grant limited Trade Union facilities to all unions.
4. Ensure more Trade Union amenities and facilities in circles where majority votes are achieved.

- 30-6-2009 Holding of lunch hour demonstration at SSA/Circle Headquarters.
- 3-7-2009 Day Long Dharna at SSA/Circle & BSNL Headquarters.
- 6-7-2009 Indefinite Hunger Strike by central Leaders at BSNL HQR.
One day token Hunger Strike at Circle / SSA levels.

All the unions of BSNL Workers Alliance as well as other friendly unions will be participating in the programme


