Sub : Request for restoration of IDA instalments to BSNL
Employees and Pensioners with retrospective effect
honouring interim order of Kerala High Court – Reg.

Kindly refer to the DPE letter cited above wherein the DOT, the Administrative Ministry is requested to take necessary action on the above matter.

In this connection this union would like to submit that BSNL Management has not entered into any wage settlement which is due from 01.01.2017 for Non-Executives. Neither implemented the wage revision for BSNL Executives as per 3rd PRC recommendations from 01.01.2017. The pension of the BSNL absorbed DOT retirees also not yet revised citing the non-revision of wages of BSNL Employees and Executives whereas the wages of all Central Govt. employees including DOT employees were revised as per 7th CPC recommendations. Similarly the pension of the DOT retirees also revised from 01.01.2016.

In these circumstances with holding of IDA arrears due to the BSNL Employees and Executives including the retirees are not covered by any orders either from the DPE or from the Govt. or DOT, to withhold the IDA increases

due from 01.10.2000 and thereafter. It should not be a double jeopardy for the BSNL employees, Executives and retirees.

This union therefore request the DOT to look into the matter personally to release the withheld IDA the BSNL employees and Dearness Relief to the IDA Pensioner as early as possible. We hope that the matter will be considered sympathetically and favourably in view of the reasons quoted in para 2 above.
