**Sub: Discrepancies in JE (Erstwhile TTA) examination held on 28-01-2018**

With reference to the subject cited above we would like to invite your kind attention on the under mentioned discrepancies and irregularities on the above subject and to take appropriate favourable action at the earliest. That there are many wrong answer Key, out of syllabus questions and questions of higher standard.

This high standard questions are meant for JTO Examination more over the syllabus is only partly covered which covered which affected the performance of the candidates. The spread of questions which are of wrong answer Key, Out of syllabus and high standard questions are given below:-

(a) Wrong answer Key = 10 NO

(b) Out of syllabus = 11 NOS

(c) Higher standard = 4 NOS

Total 25NOS.

The details of such questions are also attached here with, with explanations. Some of the questions were asked for JTO competitive examinations in the previous years. The examiner has a misconception about JE (TTA) and JTO and might have thought both JE and JTO are one and the same and question papers naturally of high standard which are meant for JTOs.

Therefore it is humbly request to you sir, that all wrong key answers, out of syllabus questions and questions of high standard may be given one mark for each such questions. In part 1 there are 20 questions and in part 11 5 questions are having problems. It is further submitted that, there is no option for out of syllabus and higher standard questions in the grievance column. There is no provision for answering more than one answer in the grievance column. This defect may be rectified.

In view of the above said facts it is humbly requested that an expert committee may be appointed to review the whole case and give full grace marks to all questions which are found out of syllabus, wrong answer key and high standard as it will adversely affect the prospects of the candidate
