Sub: Regarding Outsourcing of Broadband provisioning and Maintenance of Wireline Broadband Services.

1. Kindly refer to the letters at **Ref no1&2** above, wherein approval of management committee was conveyed regarding Outsourcing and floating of EOI of Broadband provisioning and Maintenance of Wireline Broadband Services in select locations.
2. It may be noted that a letter vide **Ref no 3** above was issued for withholding the process of floating of EOI till 30-09-2015, where presently outsourcing is not followed.
3. The issue of outsourcing of Broadband maintenance & Provisioning has been raised by the **Unions** in the 33rd National Council meeting held in BSNL CO on 16.10.15 under the Chairmanship of Director (HRD). In the meeting staff representative emphasised that they are not opposing the outsource of services in principle rather a case by case approach can be adapted .
4. It has now been decided that all the cases of Broadband provisioning and Maintenance of Wireline Broadband Services **including** those locations as communicated vide letter dated 15-05-2015(Ref 1 above) (except where EOI is already floated. It is understood that presently in Jaipur, Rajasthan circle EOI is already floated) will be examined on case to case basis by the committee formed in BSNL CO ,vide letter dated 7-09-2015 (ref 4 at above) before floating the EOI as communicated by this office vide letter dated 12-08-15 referred at 2 above.
5. All the respective circle heads are requested to kindly take necessary action and send their justified proposal for outsourcing of Broadband provisioning and Maintenance of Wireline Broadband Services by 30.11.15. Soft copy may also be sent on gmbnbbbo@gmail.com & gmco-bbin@bsnl.co.in
