With the approval of the Competent Authority, it has been decided to hold a Limited Departmental Competitive Examination (LDCE) for promotion to the Cadre of Telecom Technician (Erstwhile Telecom Mechanic) to be held on **20/08/2017 in order to fill up the vacancies for the vacancy upto 31.03.2017** as per the provision in the **Recruitment Rule of Telecom Technician (Erstwhile Telecom Mechanic)** circulated vide BSNL Corporate Office Letter No. 250-3/2012-PERS-III dated 19<sup>th</sup> Sep 2012; the scheme & Syllabus circulated vide BSNL Corporate Office Letter No. 250-74/2001-Pers-III (part) dated 18<sup>th</sup> Oct 2011 shall be applicable for same (Annexure-A & B).

The recruitment year of the LICE for Telecom Technician shall be 2016; 01.07.2016 shall be the crucial date for reckoning the eligibility of candidate for appearing in the LICE, as conveyed by BSNL Corporate Office Letter No. 250-2/2014-Estt-III dated 5<sup>th</sup> May 2017.

3. The examination will be conducted through written mode and as per revised Scheme and syllabus of examination circulated vide No. 250-74/2001-PERS-III(Part) dated 18<sup>th</sup> Oct 2011 BSNL CO. (Annexure-B). The details of Papers and Time Table of the examination will be as under :-



4. Minimum qualifying marks prescribed is 30% in each part and 37% in aggregate in respect of 'OC/OBC' candidates and 20% in each part and 30% in aggregate in respect of 'SC/ST' candidates.

5. The eligibility for appearing in the above mentioned Limited Departmental Competitive Examination shall be as per existing Recruitment Rules issued by BSNL Corporate Office Letter No. **No. 250-3/2012-PERS-III dated 19<sup>th</sup> Sep 2012 (Annexure-A)**.
6. The LDCE will be held in 28 BSNL Territorial Circles/Telecom Districts/NTR at their respective headquarters. The details of the Territorial Circles where the LDCE will be conducted are given at **Annexure-C**.
7. The employees, who are eligible in accordance with the eligible conditions as referred in the Recruitment Rules and who desire to appear in the examination should submit application offline to the **Controlling authority as nominated by the respective Circles. Data is also required to be verified thro' ERP**.
8. Applications will be considered only in the stipulated period mentioned above i.e. from **15/06/2017 to 15/07/2017 (to be done at SSA/Circle)**. Candidates will have to provide valid details as per **Annexure-D**.
9. **There shall be no examination fee.**
10. Application forms (Annexure-D) complete in every respect must be submitted on or before **15/07/2017; otherwise it will be rejected**.
11. The applicants would be admitted to the examination on the basis of the information furnished by them in their registration form. All the Candidates are, therefore, advised to ensure the fulfilment of all eligibility conditions before applying. **In case it is found at a later stage that the information furnished by an applicant is false or an applicant does not fulfil any of the eligibility conditions, the candidature of such applicants would be cancelled even if the candidate qualifies in the LICE and no correspondence in this regard would be entertained. Issuance of a Hall Ticket for the examination will NOT confer any right for promotion or otherwise. Promotion will be solely provisional subject to the fulfilment of all eligibility conditions/vacancy/merit.**
13. No electronic gadget or mobile phone etc. will be permitted to be taken inside the examination premises by the candidates.
