Respected Sir,

Sub: - Minimum pay of BSNL non executive employees as on 1.1.2017 to be revised in the wage negotiation committee of BSNL – Reg.

This Union would like to submit the following few lines for your kind consideration and favourable intervention please.

From the wage negotiation between BSNL and the recognised unions it is understood that the management has proposed a minimum of Rs.18600/- and the recognised unions are demanding Rs.19000/-. In this connection we the third largest union in BSNL would like to insist that the minimum wages of Rs.20000/- as the Port and Dock workers have recently signed an agreement for five years for a minimum pay of Rs.20900/-. The minimum pay of DOT employees also is Rs.18000+900 (Rs.18900/-) as on 1.1.2017. We hope that the difference that existed on 1.10.2000 between DOT and BSNL employees will continue to be done in the wage settlement from 1.1.2017.

Therefore there is every justification for our demand of Rs.20000/- as minimum pay.

As already given by this union the expenditure is not much and it is well within the amount of Rs.2500 crores offered by the CMD in the meeting of recognized unions and Associations on 9.8.2017 and also the CMD assured to Secretary DOT vide DO letter No. BSNL/38-2/SR/2016 dated 01-06-2017 stating that "The resources mobilization for its implementation may be left to the Board of Directors of BSNL". We hope that the staff side and the official side members of the wage negotiation committee will not let down the BSNL non executive employees before the eyes of the other PSUs
