Sub: Verification of Community Certificates of SC/ST employees – Reg.

Ref : BSNLCO, SCT Cell Letter No : 60-02/2020 – SCT (Pt) dated 17.01.2022

Kindly refer to your office letter cited above regarding verification of community certificates of Working as well as Retired employees of BSNL. In this connection this union would like to convey our deep regret to note that in the subject of the letter it is stated as, "Status of pending False certificate verification", even before it is verified and established as False or Fake. The CGM, T.N. Circle also referring the cases like this very frequently.

It is nothing but insulting the entire employees of ST Community for no fault of theirs. In fact, these certificates should have been verified by the Appointing Authorities before issue of appointment orders or immediately after appointment but before issue of confirmation orders. In some cases the communal status has been verified by the competent authorities, such as District Collector / District Magistrates. But the appointing authorities have failed to make entries in the service book of the employee and paste the verification report in the respective service book.

If any complaint is received from any individual or any organization about the genuiness of the community certificate, the **complainant should first prove his complaint** as per the orders dated 07.07.1983 of the SC/ST welfare Department of T.N. Govt. Instead of doing that, straight away sending that complaint to the SLSC **after the lapse of two or three decades**, results delay in verification at RDO or Tahsildar level to trace the old records and the employees are put into much hardship at the time of their superannuation.

It is therefore requested that appropriate instructions may kindly be issued to the Authorities concerned not to use the words of false or fake certificate in the official correspondences without verification results. We hope that you will do the needful in this regard.
