d) The notices issued by EPF/ESI authorities are not responded.
4. Any such non-compliances in your circle may kindly be addressed promptly and the information in the format enclosed in respect of contract labours may be given latest by 21.10.2015 by FAX and on mail ID restg@bsnl.co.in.
5. Further it may kindly be ensured that the information is given after due verification of the relevant Labour records. This may be appreciated that non-compliance to social security provisions not only attracts penal provisions with financial implications but also affects the public image of the organization and therefore has to be dealt with firmly. Success of such actions depends upon the maintenance of prescribed records, timely submission of statements to concerned authorities, monitoring of strict adherence to various provisions under the relevant acts/rules, prompt response to the notices from EPF/ESI authorities and taking due action against the defaulters.

The progress will be monitored by CMD BSNL therefore the information as per Annexure may kindly be given on 'Top Priority' and before 21.10.2015.
