**Subject:- Holding of Limited Departmental Competitive Examination (LICE) for promotion to the post of Junior Telecom Officer (Telecom) {JTO (T)} in BSNL.**

Sir,

With the approval of the Competent Authority, it has been decided to hold a Limited Internal Competitive Examination (LICE) for promotion to the post of Junior Telecom Officer (Telecom) {JTO (T)}, as per the Recruitment Rules of Junior Telecom Officer (Telecom)-2014, circulated vide BSNL C.O. letter No. 5-32/2013-Estt.IV dated 14/10/2015. The aforesaid LICE is to be conducted through Online examination method in a centralized manner by the Recruitment Branch of BSNL Corporate Office through the Examination Agency. However, the notification for the aforesaid LICE is required to be issued by the respective Circles. The time schedule prescribed for the aforesaid LICE is as under :-

2. In this regard, the Circles are requested to calculate the vacancies as under :-

- Total no. of posts of JTO (T) under 50% Internal Quota in the Circle;
- Total no. of officials absorbed through absorption process, as per the JTO (T) Recruitment Rules-2014 in the Circle;
- Total no. of posts to be filled up through LICE, as per the JTO (T) Recruitment Rules-2014 (i.e. remaining posts out of 50% Internal Quota, after completion of absorption process) in the Circle;
- Detailed vacancy positions – Vacancy Year-wise (separately for the years 2013-14, 2014-15 and 2015-16), Category-wise (OC, SC, ST).
