Sub: Holding of Limited Internal Competitive Examination (LICE) for promotion of Steno Grade D to the grade of PA (Personal Assistant) in BSNL corporate office.

With the approval of the Competent Authority, it has been decided to hold a Limited Internal Competitive Examination (LICE) to fill up the vacant posts in the grade of PA of BSNLCO pertaining to the vacancy years 2013-14 to 2017-18 from the eligible Stenographer Grade 'D' of BSNLCO.

- 2. The LICE will be conducted as per provisions of the Recruitment Rules issued vide letter No. 27-01/2001-CSS Dated 04.07.2003. The scheme & syllabus of LICE to the grade of PA would be same as notified vide letter No. 106-3/2005-CSS Dated 19.02.2008 and subsequent amendment made vide letter No. 106-3/2011-CSS Dated 18.04.2013.
- 3. Year-wise, category-wise vacancies will be notified in due course.

6. The examination will be of multiple choice objective type and as such each question will have 4 multiple choices for answer. Only one answer which is the most appropriate has to be selected by the candidate and click the relevant option accordingly. There will be negative marking. In case of wrong answer 25% of the marks of that question will be deducted and as such the candidates are advised not to resort to arbitrary selection of answer. The Scheme and syllabus of LICE for promotion to the Grade of PA in BSNL C.O. is enclosed as Annexure-A.

7. As per the amendment made vide letter No. 106-3/2011-CSS Dated 18.04.2013 of CSS Branch, the minimum Qualifying marks in the LDCE for PA will be as follows:-

- 9. The employees, who are eligible in accordance with the eligible conditions as referred in the Recruitment Rules and who desire to appear in the examination should submit application/nomination on-line. Candidates applying for LICE for promotion to the post of PA are required to fill their application/nomination form through online on BSNL Training Portal i.e http://10.192.209.231/ (www.training.bsnl.co.in). Nominations/Application will be considered only through the online registration process which is to start from **27.11.2018** and will be closed on **26.12.2018**. Therefore candidates are advised to visit www.intranet.bsnl.co.in for any updates regarding the LICE. AGM(CSS) BSNL Corporate Office will, in turn, approve the online nomination/application forms of eligible candidates through online within the stipulated time.
- 10. The examination will be conducted strictly in accordance with provisions of the Standard Operating Procedure (SOP) for conducting computer based online examination in BSNL.
- 11. The skill test in shorthand will be conducted through computer, CGM ALTTC Ghaziabad will arrange for computers. APS corporate 2000+++ software may be used for conducting skill test in Hindi.
- 12. Shorthand Note Book for dictation and good quality A4 sheets, with perforation for Secret code (as given in answer books), shall be supplied for Paper-II by ALTTC. Each such sheet should be signed with rubber stamp by Centre Supervisor. Pencil (for paper-II) is to be brought by the candidates.
- 13. All candidates applying for LICE for PA are required to read all the instructions provided on website http://10.192.209.231/ (www.training.bsnl.co.in) before filling the online nomination/application. Candidates will have to provide valid Email ID and Mobile Number at the time of online nomination/application. After submitting the on-line nomination/application, the applicant shall take a print out of nomination details and keep it with him/her for record.
- 14. The prescribed examination fee **Rs. 650**/-(Rupees Six Hundred Fifty only only) for the OC/OBC candidates and **Rs. 325**/- (Rupees Three hundred Twenty Five only) for the SC/ST candidates shall be paid through DD(Demand Draft) in favour of **AO(Cash) BSNL** only. The amount of the fee shall not be accepted in any other form. Fee once paid shall NEITHER be refunded under any circumstances NOR can be held in reserve for any other examination or selection. Hence, the candidates are requested to ensure their eligibility for the said LICE before applying for the same.
- 15. Examination shall be conducted strictly in accordance with the rules laid down, regulations and instructions issued in this regard from time to time. The examination shall be held in a centralized manner at ALTTC, Ghaziabad. The Chief General Manager, ALTTC, Ghaziabad, will be responsible for actual conduct of the examination.
