**Sub: LICE JTO under 50% 2016, examination held on 22.05.2016 ( VY 2013-14), 24.09.2016 (VY 2014-15) & 11.12.2016 (VY 2015-16) — review of failed SC/ST candidate reg.**

In reference to aforesaid context it is intimated that competent authority constituted a committee to review the result of failed SC/ST candidates appeared in the above mentioned LICES for JTOs for submitting their reports.

2. The said committee reviewed the results of the all failed SC & ST candidates in the light of office order No. 22-5/91-NCG dated 30.11.92 conveyed/contained in the Para-5 of minutes of meeting, issued by SR section vide No. BSNL/39-3/SR/2017 dated 16<sup>th</sup> Aug 2017 and thus issued revised guidelines on review of failed SC/ST candidates in result vide letter No.9-2/2016-Rectt dated 28-08-2017 & 52-1/2016-Rectt dated 17.10.2017 i.e. incorporated the criterion of 20% & 15% as the minimum qualifying % in each part of the papers for SC & ST candidates respectively.

3. As such based on the recommendations of the said committee, the status of result of failed SC/ST candidates appeared on the aforesaid LICES, is enclosed as **Annexure-A, B & C** (circle wise qualified candidates) for Vacancy year 2013-14, 2014-15 & 2015-16 respectively..

4. All the concerned Circles are requested to implement the reviewed status of the candidates as per vacancy position of the said LICES **vis-a-vis eligibility condition (vide RR)** of the vacancy year. In case of any doubt, the Estt. Cell BSNL CO contacted for implementing the reviewed SC/ST result of JTO (LICES) for the vacancy year 2013-14, 2014-15 & 2015-16 respectively.
