

Sub: - Deferring the agitational programme of the All Unions and Associations of BSNL - req.

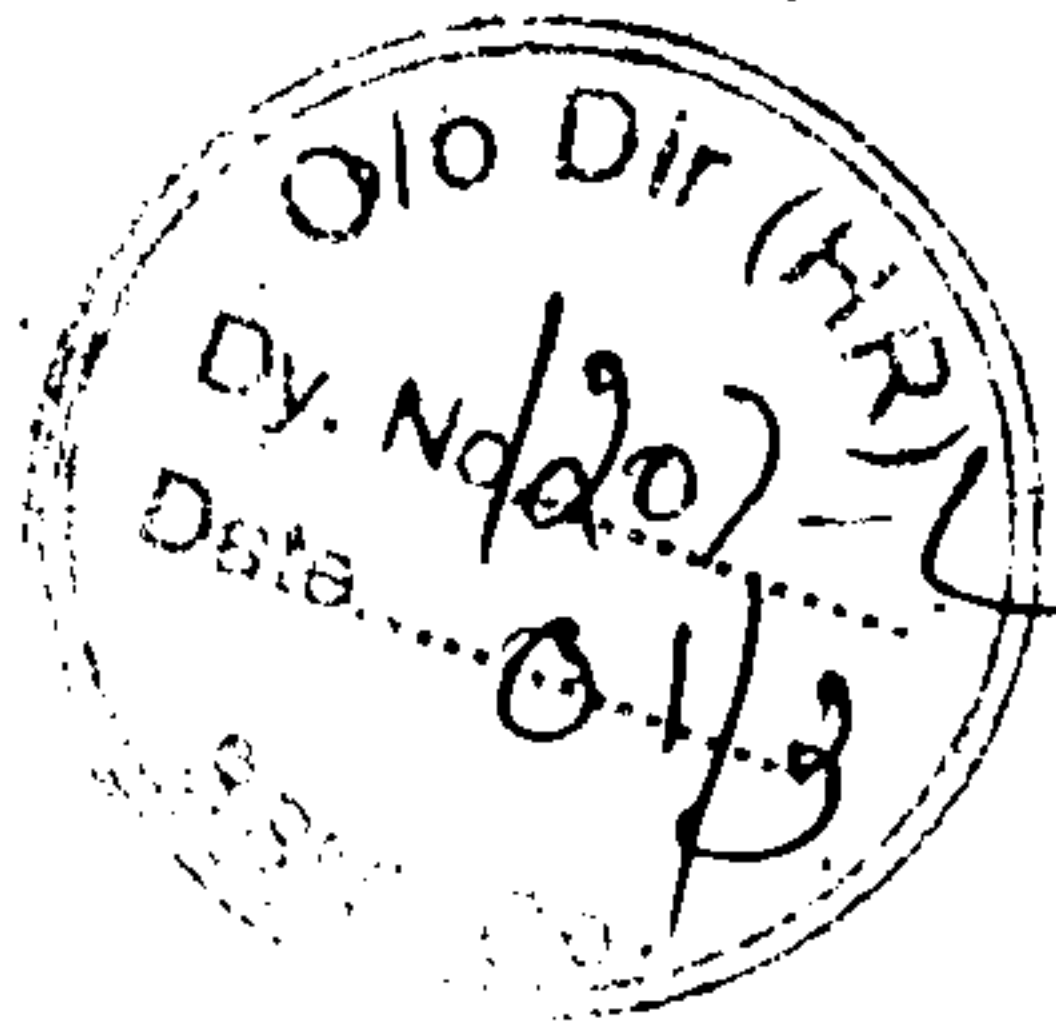
