Sub: - Regarding Empanelment of SIM vendors for supply of SIM cards in BSNL. Ref: - This office letter no. 53-104/2010-CMTS (Pt)/ dated 18/08/2015.

Kind attention is invited to this office letter under reference, whereby all telecom circles/telecom districts were requested to review the availability of SIM cards for remaining period of FY 2015-16 in reference to monthly targets of SIM activations recently issued by BSNL CO vide D.O. dated 02/06/2015.

- 2. In this regard various responses have been received at BSNL CO and it is observed that the circles have reviewed the requirement and have envisaged that there shall be requirements of additional SIMs other than those in hand/pipeline in the circles to meet the targets.
- 3. Many of the circles are contemplating to take SIMs from open market as per authorization issued from BSNL CO earlier in this regard. In this reference the undersigned is directed to convey the following:
- 3.1. Earlier, in order to expedite the procurement of items like SIMs, which are procured by BSNL on routine basis, it was suggested that BSNL may empanel SIM vendors for a specified duration, say 3 years, on basis of a pre-qualification tender in which BSNL shall invite pre-qualifications bids only. After evaluation of pre-qualification bids, all the qualified vendors will be empanelled for the stated period. Subsequently, BSNL may invite financial bids from empanelled SIM vendors for the procurement of SIMs. In this reference, MM Cell BSNL CO has recently finalized the Empanelment of two SIM vendors (M/s Syscom and M/s Sharon) for procurement of SIMs in BSNL.
- 3.2. In this regard, approval of competent authority is hereby conveyed that in order to address the shortfall of SIMs if any and to expedite tender process, circles may seek financial quotes from these empanelled vendors directly. The empanelment letters issued from MM Cell BSNL CO along with the terms and conditions are enclosed for ready reference. The tender documents for empanelment of SIM Vendor along with its clarifications are available in <u>Tenders Archieve</u> at <u>www.bsnl.co.in</u>.
- 3.3. As per the process of Empanelment, circle has to invite financial quotes from these empanelled SIM vendors only, for required type and quantity of SIMs, financial evaluation of these quotes and discovery of L1 bidder's price. Vendor with final L1 price be awarded the work to supply the entire quantity of SIMs to be procured.

- 3.4. Further, commercial condition of contract shall be as per Empanelment tender and clarifications issued against the tender, including the following exercise, to be carried out by Circle at the time of seeking financial quotes from SIM vendors.
- (a) Type of SIM Card and its quantity shall be finalized and to be intimated to empanelled vendors.
- (b) Bid security/EMD (to be submitted at the time of financial bidding) @2% of estimated value of requirement.
- (c) Delivery schedule is to be intimated.
- (d) Validity period of PBG is to be intimated (as per guidelines of procurement manual).
- (e) Court Jurisdiction for the contract /PO may be kept as per the location of circle HQ.
- 4. The above authorization to the circles to seek financial quotes as per above arrangement is valid till <u>30<sup>th</sup> September 2015</u> only.


