It is an encouraging factor that, this time also General Secretaries / Representatives of all the constituents of the AUAB attended the meeting. Com. V. Subburaman, GS, TEPU, presided over the meeting and welcomed all. Com. P. Abhimanyu, Convenor, too welcomed all and proposed the agenda for the meeting. He also made briefings on the agenda items. After detailed discussions, the following decisions are taken: -

- (1) The movement of submitting memorandum to the MPs, has started from 13.07.2020 and it will go on till 31.07.2020. The meeting decided that, submission of the memorandum to the MPs should be expedited, despite the imposition of lock-down in many areas and also restrictions in movement, to contain the COVID-19.
- (2) As regards the Twitter campaign, a hashtag is to be created focussing on 4G and BSNL's revival. An updating is to be made on the websites of the constituents, explaining how to open the Twitter account.
- (3) As regards asset monetisation, the meeting decided that, BSNL's surplus lands should be sold only at market price and should not be sold at circle / book value.
- (4) The meeting decided that, in the name of monetisation of assets, the towers and optic fibre of BSNL should not be handed over to the private. It is decided that letters should be written in this regard to the Prime Minister and to the CMD BSNL.
- (5) The meeting severely criticised the BSNL Management for not paying salary on time. Strong views were expressed in the meeting, suggesting that serious forms of agitations should be organised on this issue.
- (6) The meeting expressed it's extreme unhappiness over the fact that, the CMD BSNL is not inviting the AUAB for any talks, despite this joint platform is taking up burning issues of the Company and the employees and is also organising agitational programme.
- (7) Discussion took place regarding broadening unity and bringing all organisations into the struggle. It is inconclusive and will continue in the next meeting.
