

Subject: Rationalization of 'Speed Restoration Plans' to restore the speed to the normal when the speed is downgraded due to crossing of the usage as per the FUP under unlimited broadband plans - reg.

1. Kindly refer to the letter No. 1-1/2014-R&C (CFA) [Circular R&C-CFA No. 79/14-15] dated 15-12-2014 vide which 'Speed Restoration add-on Plans' to restore the speed to the normal when the speed is downgraded due to crossing of the usage as per the FUP under unlimited Broadband plans in all the circles, were issued.
2. Now, the Competent Authority has decided **"to reduce the charges of 'Speed Restoration add-on Plans' (as issued vide BSNL C.O. letter No. 1-1/2014-R&C [CFA], circular No. 79/14-15 dated 15-12-2014) to restore the speed to the normal when the speed is downgraded due to crossing of the usage as per the FUP under unlimited DSL/FTTH Broadband plans in all the circles as follows:-"**

Speed restoration add-on plan Name (available on ADSL and FTTH both)	Restoration of original higher speed for the data usage upto	Existing Speed restoration plan charges in Rs. (excluding service tax)	Revised Speed restoration plan charges in Rs. (excluding service tax)
Speed restoration- 2GB plan	2 GB	100	50
Speed restoration- 5GB plan	5 GB	200	100
Speed restoration- 10GB plan	10 GB	300	150
Speed restoration- 20GB plan	20 GB	500	250

3. **The above speed restoration plan will expire after exhausting the data usage as mentioned above or on completion of billing cycle, whichever is earlier.**
4. The above instructions are **applicable w.e.f. 17-04-2017 in all the circles.**
5. All other terms and conditions shall remain the same.
6. **The circle shall ensure to comply with all regulatory mechanism.**
7.
