Sub:- Implementation of Revision of Pension of Pre-2016 Pensioners/Family Pensioners under 7<sup>th</sup> CPC in pursuance to DOP&PW OM No. 38/37/2016/-P&PW(A) dated 12<sup>th</sup> May 2017 and MoF(Deptt. Of Expenditure) OM No. 1 (13) EV/2017 dated 23<sup>th</sup> May 2017.

Sir,

I am directed to refer to this office letters of even no. dated 20/6/2017 and 28/6/2017 on the above subject and to say that DOT has informed on 31/7/2017 to CMD, BSNL that no case has yet been forwarded by BSNL units to the respective CCA office for revision of pension of pre-2016 pensioners in pursuance to above referred letters. DDG(Accounts), DOT has further reminded to CMD, BSNL on 9/8/2017 and expressed his concern over inordinate delay in revision of pension of pre-2016 pensioners under 7<sup>th</sup> CPC. As per report it is also observed that the instructions issued by this office on 20/6/2017 is also not adhered to by the concerned GM of your circle. Further, your Circle has not uploaded the required data on this matter as instructed vide this office letter dated 28/6/2017. In this regard, it is also informed that a Concordance Table has also been circulated vide this office letter dated 27.7.2017 and 10.8.2017 to facilitate early revision of notional pay of pre-2016 CDA retirees as per para-4 of OM dated 12/5/2017 already circulated under this office letter dated 8/6/2017.

2. DoT also suggested that BSNL can depute 2-3 officials for this activity. It is further emphasised that top priority may be given to senior officers in two specific time period i.e. 1986 to 2000 and 2000 to 31.12.2015. Accordingly, you are again requested to give directions to concerned GM(who is handling pension revision cases of your circle) to revise the pension of pre-2016 CDA pensioners and compile the process urgently and upload the data on or before 15.9.2017 as required by this office letter dated 28/6/2017 without any fail. The delay in uploading data in the prescribed format has been viewed by Dir(HR) seriously.
