It has been decided to hold a Limited Internal Competitive Examination (LICE) to fill up the vacant posts in the grade of Assistant Manager of BSNL C.O. pertaining to the recruitment year 2015-2016 as per the provisions of the Recruitment Rules issued vide BSNL C.O. letter 27-1/2001-CSS dated 4<sup>th</sup> July, 2003 and amendment issued by OM No. 27-1/2001-CSS dated 29<sup>th</sup> July, 2013.

2. The scheme and syllabus of the examination will be as circulated vide BSNL C.O.'s O.M. No. 140-1/2005-CSS dated 18-08-2005 and subsequent partial modification issued by OM No. 140-1/2005-CSS dated 1-2-2007. The details of papers and time —table of the examination (LICE) will be as under:-

\*Paper –I (Objective multiple choice) Examination will be conducted on online mode at the ALTTC examination center, Ghaziabad.

3. Eligibility to appear in the above examination shall be strictly in accordance with the CSS Branch circular stated in Para 1 above. Any doubt regarding eligibility for admission to the examination may kindly be addressed to AGM (CSS), BSNL Corporate Office, 4<sup>th</sup> floor, Bharat Sanchar Bhavan, New Delhi. Officials who are eligible in accordance with the eligibility conditions and who desire to appear in this examination should submit their application in the enclosed Proforma to DGM (Pers.-II), BSNL Corporate Office on or before 10.02.2016 and also has to fill their nomination form through online on BSNL Training Portal i.e. www.training.bsnl.co.in. Online nomination will be made from 20.01.2016 to 10.02.2016. Application will not be received in any circumstances after the due date, i.e., 10.02.2016. AGM (CSS) BSNL Corporate Office will, in turn, approve the online nomination forms of eligible candidates through online, latest by 25.02.2016.





- 4. Examination shall be conducted strictly in accordance with the rules laid down in Appendix No. 37 of P&T Manual Vol IV (Fifth Edition) and instructions issued in this regard from time to time. The examination shall be held in a **centralized manner at ALTTC**, **Ghaziabad**. The Chief General Manager, ALTTC, Ghaziabad, will be responsible for actual conduct of the examination.
- 5. As per letter No. 2-12/2011-Rectt.-I dated 24-05-2011 the minimum Qualifying marks are as under:-
  - (i) 30% in paper-I, 37% in Paper-II and 37% in aggregate for OC category.
  - (ii) 23% in paper-I, 30% in Paper-II and 30% in aggregate in case of SC/ST candidates.
- 6. Paper-I of the Examination will be conducted through Online mode. Each question will have four options for answer. Only one answer which is the most appropriate has to be selected by the candidate. Candidate is required to click on the relevant bubble by mouse of Computer only. In case of wrong answer, 25% marks would be deducted for each incorrect answer and as such the candidates are advised not to resort to arbitrary selection of answer.
- 7. Eligible candidates may download their Admit Cards from BSNL Training Portal <a href="https://www.training.bsnl.co.in">www.training.bsnl.co.in</a> 15 days before the date of examination.
- 8. The ALTTC, Ghaziabad may communicate the information as detailed below to Rectt. Branch BSNL CO latest by **28.01.2016** positively.
  - (i) Name/Address/Telephone Nos.(Office, Residence and Mobile)/E-mail Address of the exam Co-ordinator,
  - (ii) Name, Designation and Address of the Supervising Officer.
- 9. The prescribed examination fee {Rs. 500/- (Rupees Five Hundred only) for OC/OBC and Rs. 250/- (Rupees Two Hundred Fifty only) for SC/ST candidates) through Demand Draft only. The Demand Draft should be drawn in favour of Accounts Officer (Cash), BSNL payable at New Delhi. The candidates are required to upload the copy of the Demand Draft during the Online Registration process. However, they have to submit the Demand Draft in original to the Centre Supervisor at the Examination Centre at the time of written examination, failing which the candidate will not be allowed to appear in the written examination.

The amount of the fee shall not be accepted in any other form. Fee once paid shall not be refunded under any circumstances/ nor can be held in reserve for any other examination or selection.

- 10. No electronic gadget or mobile phone will be permitted to be taken inside the examination premises by the candidate.
