- (i) Conduct Circle HPC latest by 31-5-15.
- (ii) Send the minute's of Circle HPC alongwith approval of CGM for obtaining concurrence of this office latest by 15-6-2015.
- (iii) Send the details of cases received till 31-3-15 which could not be considered for want of some documents.
